For phased projects, the fee is based on the total acreage of the phase being submitted.

* Plus \$150.00 per acre over the 50 acre base fee of \$6,500.00

Minor amendment is \$100.00 per amendment or \$100.00 per increased acre(s) (\$100.00 minimum). Major amendment is submission of new Notice of Intent and all fees applicable.
